**Sub:** Mandatory furnishing/updating of PAN, full KYC details and Nomination

**Ref:** SEBI Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/655 Dated November 3, 2021 read together with SEBI Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/687 dated December 14, 2021 (the "SEBI Circulars")

Securities and Exchange Board of India (SEBI) vide the above SEBI Circulars has made it mandatory for Physical shareholders to furnish PAN, address, email address, mobile number, Bank account details and nomination details. Folios wherein any one of the said details are not available on or after 1<sup>st</sup> April, 2023, shall be frozen and shareholder will not be eligible to lodge grievances or avail service request from the RTA. Further, shareholders holding share in physical mode are requested to ensure that their PAN is linked to Aadhaar by 31<sup>st</sup> March, 2022 or any other date as may be specified by Central Board of Direct Taxes (CBDT) to avoid freezing of folio.

Further, as per the above SEBI Circulars, RTA/ Company shall refer the frozen folios to the administering authority under the Benami Transaction (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002, after 31<sup>st</sup> December, 2025.

Keeping in view the above requirements the members holding shares in physical mode are requested to submit the following documents to the RTA i.e Maheswari Datamatics Private Limited, at the earliest.

- 4. Service portal of the RTA with e-sign with scanned copies of documents, if the RTA is providing such facility

#### Note

- It is mandatory for holders of physical securities in listed company to furnish PAN, full KYC details (address proof, bank details, e-mail address, mobile number) and Nomination (for all the eligible folios).
- Upon receipt or up-dation of bank details, the RTA will automatically, pay electronically, all the moneys of / payments to the holder that were previous unclaimed / unsuccessful.
- RTA shall update the folio with PAN, KYC details and Nominee, within seven working days of its receipt. However, cancellation of nomination, shall take effect from the date on which this intimation is received by the company / RTA.
- RTA shall not insist on Affidavits or Attestation / Notarization or indemnity for registering / up-dating / changing PAN, KYC details and Nomination.
